Well... it looks like my nameplate will be lonely again.  I don't think i'll be at the luncheon today. But I do have a couple of things for you, Nan Kiel...

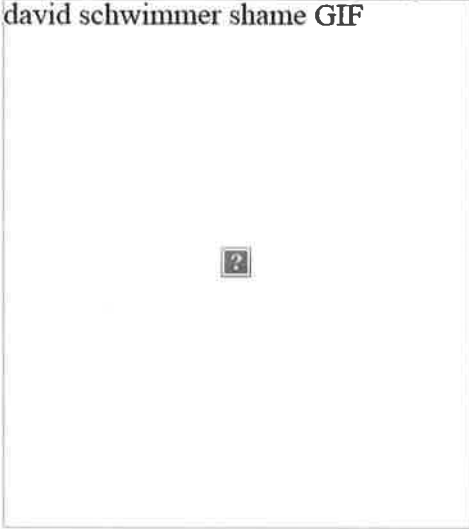
